In consideration of being allowed to participate in any way in Tahoe Sports and Entertainment (TSE) RINK PROGRAMS, and or any other related ENRICHMENT PROGRAM activities.

I _____, the undersigned, acknowledge, appreciate, and agree that:

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown of my participation in all RINK PROGRAMS (including but not limited to ice skating, skate school, freestyle, curling, broomball, weight training, exercise, lacrosse, dry land and hockey. Herein referred to as "RINK PROGRAMS"), EVEN IF ARISING FROM THE NEGLIGENCE OF RELEASEES or others, and assume full responsibility for my participation; regardless of location that injury occurs, (on or around premises, or at offsite locations) and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation in RINK PROGRAMS. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
4. I, for myself and Participant on behalf of my heirs, assigns, personal representative and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS THE TAHOE SPORTS AND ENTERTAINMENT, INC. (TSE) operating company of the South Lake Tahoe Ice Arena, their officers, officials, agents and/or employees, other participants, partners, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises, used to conduct the RINK PROGRAMS ("Releases"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
5. I, for myself and Participant on behalf of my heirs, assigns, personal representative and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS THE CITY OF SOUTH LAKE TAHOE, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, partnering associations, advertisers, and, if applicable, owners and lessors of premises used to conduct the RINK PROGRAMS ("Releases"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
6. Arbitration: In further consideration of allowing me to participate in the aforementioned activities, I hereby agree to submit to binding arbitration any and all claims which I believe I may have against the facility arising from my activities at the facility. The arbitration shall be pursuant to the rules of the American Arbitration Association. The arbitrators shall apply the Federal Rules of Evidence to all proceedings. Arbitration shall be commenced with one (1) year from the date on which any alleged claim first arose. Further, the arbitration shall be held in the town where the Arena is located, unless otherwise mutually agreed by all parties. The submission of to the American Arbitration Association shall be unlimited and the arbitration award may be enforced by any court of competent jurisdiction.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
